1. Fill in all blank spaces and sign in space provided.
2. Provide site drawing with property lines marked, showing the proposed location of the structure. Measure distances from structure to property lines. Show all existing structures, utility or drainage easements, if known, and **wetlands** boundaries, if applicable. Applicant must understand that all structures setback lines shall be **10 ft** from property lines **and 30 ft** from road right-of-ways. Applicant acknowledges that if the location of the structure covered by this permit does not comply with these requirements, the applicant will be required to move the structure to bring it into compliance at applicants' expense.
